SMFL Announces Strategic Long-Term Partnership with Brookfield's Triton International

Sumitomo Mitsui Finance and Leasing Company, Limited (President: Masaki Tachibana, "SMFL") is pleased to announce a strategic long-term partnership with Triton International ("Triton"), a portfolio company of Brookfield Infrastructure Partners ("Brookfield"). Through this partnership, SMFL has acquired a minority stake in one of Triton's leased container portfolios and will have the option to invest in additional Triton assets over time.

As part of its global strategy, SMFL invests in highly liquid and relatively stable assets across three key sectors, including aircraft leasing, helicopter leasing, and aircraft engine leasing. SMFL believes container leasing is a highly attractive and complementary addition to its existing portfolio, and that these assets exhibit the stable long-term growth characteristics it looks for in all its investments. By entering the container leasing sector, SMFL will grow its revenue base and add to the diversification of its existing global asset portfolio.

SMFL plans to leverage its strong partnership with Brookfield and Triton's global platform to position container leasing one of the key drivers of its medium-to-long-term growth plan.
